

Defiance County Fair Admission Agreement 2026

The Defiance County Fair Board seeks volunteer organizations that will provide personnel to sell admission tickets and manage gate operations during the Fair as a fundraising opportunity for participating organizations. Organizations selected will be responsible for staffing assigned gates and ensuring proper handling of ticket sales and funds.

Dates, Hours, and Compensation

Each day may be divided into multiple shifts. Standard shift change times are 12:30 PM and 4:30 PM to allow for proper reconciliation of tickets and cash. Days are scheduled as follows:

- Saturday Aug 22, 2026 – \$800 – 30 people – 8:00 AM to 9:00 PM
- Sunday Aug 23, 2026 – \$800 – 30 people – 8:00 AM to 9:00 PM
- Monday Aug 24, 2026 – \$650 – 26 people – 8:00 AM to 9:00 PM
- Tuesday Aug 25, 2026 – \$600 – 24 people – 8:00 AM to 9:00 PM
- Wednesday Aug 26, 2026 – \$600 – 24 people – 8:00 AM to 9:00 PM
- Thursday Aug 27, 2026 – \$800 – 30 people – 8:00 AM to 9:00 PM
- Friday Aug 28, 2026 – \$850 – 32 people – 11:00 AM to 9:00 PM
- Saturday Aug 29, 2026 – FREE ADMISSION DAY – No gate staffing required.

Staffing Requirements

The Organization must provide the required number of volunteers for all assigned gates. One runner must be provided per shift to assist with change and breaks. A supervisor must be assigned for each shift and remain accountable for ticket and cash reconciliation. A \$75 penalty will be assessed for each unstaffed gate.

Ticket and Cash Handling

Supervisors will sign out tickets and change at the Secretary's Office at the start of each shift and return all funds and tickets at shift end. Supervisors must remain until cash is reconciled and verified. Money shortages will be deducted from final payment.

Meetings and Training

All supervisors must attend a mandatory planning meeting prior to the Fair.

Selection and Approval

Participation is subject to approval by the board gate committee based on past performance, staffing reliability, and overall readiness to fulfill the responsibilities outlined above.
